UNDERTAKING

I, Md. The Society resolution No 23/2015 dated 22/05/2015 authorized the undersigned to make an application to the ERC, NCTE for grant of recognition D.El.Ed. (course) with an intake of 100 (Two Units), I do hereby solemnly affirm and state as follows:-

- (i) That I have read all the provisions of the NCTE Act, Rules & Regulations. The application of the institution has been submitted as per the provisions of NCTE Regulation, 2014. That the institution of the management shall be run under the society namely Gramsalika Sree Ramkrishna Welfare & Service Society.
- (ii) That the society is eligible as per the clause 4 of the NCTE Regulation, 2014 - Self financed educational institution established and operated by 'not for profit' societies and trusts registered under the appropriate laws or a company incorporated under the Companies Act, 2013 (18 of 2013)
- (iii) That the institution is in possession of legally valid documents and conversion of land has been obtained from the competent authority as per the provisions of the law of the concerned state.
- (iv) That the institution has constructed building on the legally valid land possessed by the institution as per the provisions of the NCTE Regulations. The construction of the building is complete in the form of a permanent structure. There is no temporary structure or asbestos roofing.

(v) That the institution undertake that the building of the institution is constructed keeping in view the provisions and by-laws of the building construction as per the bureau of standards and the same is fully safe and secure to run the teacher training course. The safeguard against fire hazard has been provided in all parts of the building. The institution has submitted the building completion certificate as per the prescribed format.

(vi) That in addition to the above infrastructural, instructional and other facilities are provided as per the NCTE Regulations, norms, standards and guidelines prescribed from time to time.

(vii) That the admission to the course will be made only after recognition is granted by the concerned Regional Committee of the NCTE and affiliation is granted by the concerned Affiliating body.

(viii) That the admission of students, satisfying the eligibility conditions shall be made on merit on the basis of marks obtained in the qualifying examination and / or in the entrance examination or any other selection process as per the policy of the State Government / U.T. Administration and the University.

(ix) That there shall be reservation of seats for SC / ST / OBC other categories etc. as per the policy of State Govt.

(x) That the supporting and other staff will be appointed as per the guidelines of the State Govt. / the affiliating University.

(xi) That the institution shall charge only such fee as prescribed by the affiliating body / State Govt. concerned in accordance with the provision of NCTE (guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education institutions) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.

(xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt. / University from time to time through bank.

(xv) That the accounts of the institution will be properly maintained and audited annually by the audit authorities or a Chartered Accountant, and will be open for inspection.

- (xvi) That the Management will strictly follow all the conditions and norms prescribed by NCTE from time to time, conduct the programme in all earnestness, and submit itself to inspection by the NCTE.
- (xvii) That the institution shall make the information or documents available to NCTE or its authorized representatives as and when required by them. Failure to produce or show any required documents, shall be treated as a breach of the conditions of recognition.
- (xviii) That the institution shall records or registers and other documents etc. which are essential for running of an educational institution especially those prescribed in the relevant norms and standards and guidelines or instructions or rules etc. of the Central or Union Territory Governments, affiliating examining bodies.
- (xix) That the institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information n its Official website.
- (xx) In the event of non-compliance by the AI – Hilal Mission Teachers Training Institute with regard to the norms and standards and any other condition laid down / prescribed by the NCTE from time to time, the NCTE or a body or a person authorized by it will be free to take all necessary measures for effecting withdrawal of its recognition or permission, without consideration of any other issue, and that all liabilities arising out of such a withdrawal would solely be that of the Institution / Management.
- (xxi) That the Management will not cause or allow discontinuation of the course in any year or for any batch, and that where compelled, it will seek the concurrence of NCTE for discontinuation on the completion of the year / batch.
- (xxii) The AI – Hilal Mission Teachers Training Institute by virtue of the approval given by the NCTE shall not automatically become claimant of any financial grant or assistance from the Central or State Govt., or support from the NCTE.
- (xxiii) That the Managing Committee of the institution has been formed as per the guidelines of the State Govt. / Affiliating University.
- (xxiv) That the Management undertakes to submit Performance Appraisal Report regular as per provisions of the NCTE Act, Rules & Regulations.
